## **Maynard's 150th Birthday Celebration**

We have been speaking with the planners of the Maynard Sesquicentennial for which many activities have been delayed thru Sept 2021 due to the coronavirus pandemic.

The Committee has invited us all to participate in some impressive permanent historical markers they are designing, including panels about Digital, that will remain in downtown Maynard, and all donors will be acknowledged by name. The DEC Connection will be making a contribution towards the signage display, but individual contributions are also being solicited.

From ex-Digital VP Jack Mackeen, who serves on the Committee: This marker is a permanent installation consisting of three two-post installations in a line, each having panels front and back for a total of six panels. Completed installation will be about 12 feet long. We are still working on the back, which will include current mill info, a dedication letter noting the Sesquicentennial and a listing of officials and contributors. Planned location is in the Ken Olsen Plaza at the corner of Main and Walnut, but further up Walnut so there is no interference with driver visibility. Part of that process is trying to get Ken Thompson's games written for Graphics 2 to work, but we need more detailed info. Currently we are especially curious about how the character table and non-printable characters were handled in Graphics 2. "The Graphic 2, later manufactured for Bell Labs and Western Electric by the Digital Equipment Corporation, saw wise use in computer-aided design of printed-wiring boards, logic schematic drawings, and office-equipment layouts."


