Annual Enrollment

Get ready! HP retiree benefits enrollment is October 7 – 25

2020 retiree benefits enrollment is just around the corner. This is your once-a-year chance to review your coverage options and choose the one that's right for you. Read on to learn about upcoming communications, Benefits Fairs, and teleconferences to help you prepare to enroll.

2020 Annual Enrollment communications for retirees:

- Pre-enrollment postcard (mailed to home in early September)
- 2020 U.S. Retiree Benefits Enrollment Guide (coming soon to Continuum and mailed to your home in early October if you are currently enrolled in HP benefits)

Along with your enrollment guide, you'll receive a personalized letter explaining your coverage options and rates, and a new insert helping you find the pages in the enrollment guide that apply to you.

Starting on October 7, you can also log into [MyHPBenefits.com](https://myhpbenefits.com) to review your plan options and costs for 2020, and make your annual enrollment election for 2020.

Important: If you are not currently enrolled for coverage through HP or the Aon Retiree Health Exchange, you will **NOT** receive annual enrollment materials as you are not eligible to enroll for benefits during the annual enrollment period. You would only be eligible for coverage by calling the Benefits Center within 31 days of losing your existing coverage.

*If you are **not** currently enrolled in an HP plan, but would like to know what your rates would be if you did enroll, you can call the HP Benefits Center at 800-890-3100. The HP Benefits Center can provide your 2020 plan options and rates for comparison.*

- Go to www.webex.com.
- Enter the meeting number, your name, email address, and meeting password.
- If you receive a message about security steps to join the meeting, follow the directions on your screen.

During the teleconferences, you can listen to a presentation and have the opportunity to ask questions. (**Note:** There is a maximum of 200 participants for the UHC Medicare Advantage PPO sessions, so you may want to dial in five to ten minutes ahead of time.)
